Tuesday 12 April 2022

[Lings v. Denmark \(application no. 15136/20\)](#)

The applicant, Svend Lings, is a Danish national who was born in 1941 and lives in Kværndrup (Denmark).

The applicant is a doctor and the founder of a pro-assisted suicide organisation, Physicians in Favour of Euthanasia (*Læger for Aktiv Dødshjælp*). The case concerns his conviction on two counts of assisted suicide, and one count of attempted assisted suicide. He asserts that he was just disseminating information about suicide.

Relying on Article 10 (freedom of expression) of the European Convention on Human Rights the applicant complains that the final domestic-court decision breached his right to free expression.
